ABSTRACT

Supporting the recovery of Syria's electricity sector is essential to address urgent needs and enable long-term development. Years of conflict have severely damaged infrastructure, limiting electricity supply to 2-4 hours daily and constraining key sectors such as water, agriculture, and housing. Rehabilitating the grid is a critical first step to restore basic services, support economic recovery, and facilitate the return of displaced populations, contributing to broader stability and future development.

PROJECT COMPONENTS

Component 1: Rehabilitation of Damaged High-Voltage Transmission Lines (estimated cost of US\$ 25 million)

The procurement notice for the supply of two lines of cleaning vehicles and two lines of fault detection vehicles is expected to be published in June 2026. Package 1 has already been completed.

Component 2: completed

Component 3: Technical Assistance for Electricity Sector Development and Institutional Capacity Building (estimated cost of US\$ 5 million):

Component 3 will provide Technical Assistance to (i) inform key electricity sector strategies, policy and regulatory reforms, and investment plans for medium to long term sustainability; and (ii) support the electricity sector institutional capacity to implement these strategies and reforms.

Procurement notices for power system planning software licenses and six consulting service packages are expected to be published between June and December 2026.
