ABSTRACT

The Project aims to enable critical road infrastructure repairs on the road links that are part of the TEN-T corridor.

PROJECT COMPONENTS

Component 1: the capital repair of M-09 Ternopil – Lviv – Rava-Ruska road section between Lviv and Rava-Ruska;

Component 2: restoration of operational condition and safety improvements on the sections of M-06 Kyiv-Chop road in Kyiv, Zhytomyr and Rivne regions;

Task C. Assess the feasibility of employing independent contract engineers for state-funded road works contracts.

Task D. Assess specific requirements for direct contracting / direct negotiations procedure for road works contracts.

Task E. Enhance the capabilities of stakeholders involved in road sector procurement.
