ABSTRACT

The procurement aims at supplying the beneficiary Ukrainian company (the Buyer) with energy equipment).

Financing for the supply of the goods comes from the Ukraine Energy Support Fund. The Energy Community Secretariat, acting as manager and fiduciary of the Fund, is responsible to pay on behalf of the Buyer directly the Supplier of the goods.
