ABSTRACT

The procurement aims at supplying the beneficiary Ukrainian company (the Buyer) with protective equipment).

Financing for the supply of the goods comes from the Ukraine Energy Support Fund. The Energy Community Secretariat, acting as manager and fiduciary of the Fund, is responsible to pay on behalf of the Buyer directly the Supplier of the goods.

PROJECT COMPONENTS

- Lot 1 – Rapidly deployable modular civil protection shelters for Dnipro region – 10 pc (up to 10 persons, up to 15 persons, up to 35 persons, up to 50 persons, up to 60 persons, up to 65 persons, up to 100 persons)
- Lot 2 – Rapidly deployable modular civil protection shelters for Mykolaiv region – 2 pc (up to 25 persons and up to 85 persons)
- Lot 3 – Rapidly deployable modular civil protection shelters (up to 25 persons) for Sumy region – 6 pc
- Lot 4 – Rapidly deployable modular civil protection shelters (up to 20 persons) for Kharkiv region – 1 pc
- Lot 4 – Rapidly deployable modular civil protection shelters (up to 30 persons) for Chernihiv region – 2 pc
- Additional devices (according to Technical Specifications of Goods) – 22 sets
- Installation supervision services
