ABSTRACT

1. PROJECT MANAGEMENT UNIT CONSULTANCY FOR STATE SPECIALISED ENTERPRISE CHORNOBYL NUCLEAR POWER PLANT TO SUPPORT

International Chernobyl Cooperation Account (ICCA) activities:

- Develop the ICCA Work Plan for Chornobyl and assist with its approval with stakeholders;
- Support administration and management of the existing ICCA Grant Agreements with SSE "ChNPP" as a Recipient;
- In accordance with the agreed ICCA Work Plan for Chornobyl assist with preparation of inputs for separate ICCA Grant Agreements;
- Based on the best international practice and compliance with EBRD's Procurement Policies and Rules, propose contracting strategies and prepare procurement plans for selected projects under ICCA Grant Agreements;
- Develop tender documentation and support the PMU with the procurement process in accordance with EBRD Procurement Policy and Rules;
- Oversee and manage the implementation of the awarded contracts financed under the ICCA Grant Agreements;
- Prepare Environmental and Social Action Plans for projects financed under ICCA Grant Agreements in compliance with applicable EBRD's Environmental and Social Policy;

- Ensure provision of all required technical expertise for the PMU, including but not limited to the fields of procurement, legal, technical, financial, environmental and social.
- Establish a transparent and robust regular reporting framework on PMU support and activities financed and related to ICCA funding.
