ABSTRACT

The Project aims to:

- Ensure sustainable and efficient operation of the existing combined heat and power plants (CHP) and boiler houses in the City of Kyiv;
- Improve the reliability of heat transportation, modernize the district heating system;
- Enhance the quality of heat and hot water services to residential and non-residential customers

PROJECT COMPONENTS

Component 1: Supply, installation and commissioning of cogeneration units at CHP-6 (Installation Gas Driven CHP Plant at CHP06)

Component 2: Supply, installation and commissioning of heat storage at CHP-6 (Installation of 20 000m³ Storage Tank)

Component 3: Supply, installation and commissioning of condensing economiser at CHP-5 (Installation of Flue Gas Condensation Plant at CHP-5)

Component 4: Boiler Houses Rehabilitation

- Rehabilitation, Decommission and closure of Gas Boilers at Boiler House 1, Boiler House 2, Boiler House 3, Boiler House 4, Boiler House 5 in Kyiv
