
This flyer provides an overview of the consulting and funding services for climate protection*and adaptation to climate risks for companies with international business in emerging and developing countries.

*Climate protection includes measures that counteract global warming and the climate crisis and help reduce greenhouse gases. The term "climate adaptation" covers measures to adaptto the new climatic conditions.





The Services



Supporting the development of climate protection and climate resilience services

To provide companies with useful tools for climate protection and adaptation to climate risks, the Business Scouts - in close cooperation with competent partners from the private sector and development cooperation - offer numerous services.

- Under the title of "Decarbonization Manager" Business Scouts implement qualification programmes on CO2 management for companies in selected countries.
- Business Scouts advise on the application of GIZ's Climate Expert Tool, which includes a cost-benefit analysis as well as a management tool for the assessing of climate risks in supply chains and resulting adaptation measures for products and production.
- Business Scouts promote operational projects on climate-friendly energy and resource management in the context of training programmes in emerging and developing countries. Among these are the European Energy Manager (EUREM) or the International Water Manager for Industries (IWAMI).
- Business Scouts make use of their broad network and expertise in order to identify project opportunities for companies and support them in the implementation of their cooperation projects.



Advice on the adaptation to climate risks and on business opportunities using climate-friendly solutions

- Business Scouts provide access to funding and financing options of development cooperation on climate change mitigation, climate resilience and climate risk management. Additionally, they point out opportunities for successful cooperation.
- Together with partners, Business Scouts develop and implement qualification programmes on climate risks in international supply chains. These include webinars for various industries such as textiles, agriculture, and food.
- Business scouts specialized in skilled crafts support cooperation projects on sustainable construction in selected countries.

- Business Scouts share cooperation opportunities for climate protection within the framework of development cooperation via digital platforms, provide advice and initiate contacts between companies. This is done, for example, via the digital platform www.leverist.de.
- Business scouts provide companies with climate expertise from development cooperation and provide orientation for entrepreneurial activities in developing and emerging countries.


